

NOTICE

Dear Valued Customer:

On September 9, 2022, Superior Wastewater Systems, LLC filed a Joint Petition with Staff of the Tennessee Public Utility Commission to increase the rate for wastewater service. Superior Wastewater (formerly known as King's Chapel Capacity, LLC) has provided wastewater service since 2005.¹

The Company has never increased its service rate during its seventeen years of operations. Although Superior Wastewater has made efforts to control the costs of providing services, the proposed service rate increase is necessary to cover revenue shortfalls due to increases in operating expenses and taxes.

In sum, Superior Wastewater is requesting the following rate change:

*** The monthly rate includes a \$10.13 escrow charge. The monthly rate does not include annual bonding costs which are passed through to customers with no markup by the Company. The monthly rate also excludes currently authorized surcharges and taxes.**

The Joint Petition requests that a rate hearing be conducted in this matter on October 10, 2022, and that the proposed rates become effective upon the Commission's approval. The rate hearing is open to the public, including an opportunity for public comment, and will be held at 9:00 a.m. on October 10, 2022, in the Hearing Room on the Ground Floor of the Andrew Jackson State Office Building, 500 Deaderick Street, Nashville, Tennessee 37243. At least ten days prior to hearing, a separate notice will be issued on the Commission's website and filed in Docket No. 22-00087 that will include information regarding electronic participation.
