**ORDER ESTABLISHING PROCEDURAL SCHEDULE FOR HEARING ON RATE CASE  
EXPENSE**

This matter came before the Hearing Officer of the Tennessee Public Utility Commission (“Commission” or “TPUC”) upon a Status Conference held on May 16, 2023, to discuss the *Consumer Advocate’s Motion to Amend Procedural Schedule* (“*Motion*”) and to set dates for the filing of testimony regarding the post-hearing issue of Superior Wastewater Systems, LLC’s (“Superior”) recovery of certain expenses related to its staff assisted rate case.

In its *Motion*, the Consumer Advocate Division of the Office of the Tennessee Attorney General (“Consumer Advocate”) requested that a date be set for the Consumer Advocate to respond to the *Proposed Recovery by Superior Wastewater Systems, LLC If [sic] Its Incurred Legal, Regulatory, Administrative and Delay Costs Associated with the Intervention of the Consumer Advocate in This Docket*. During the Status Conference, the Hearing Officer determined that in addition to testimony regarding the amount of rate case expense, legal briefs also would be necessary on the issue of delay costs as part of the rate case expense. Accordingly, the Hearing Officer granted the Consumer Advocate’s *Motion* and established the procedural schedule as set forth in **Exhibit A** attached to this Order.
