TARIFF FILING FOR RECOVERY OF RATE CASE EXPENSE

Dear Ms. Mairs:

On August 14, 2023, in Docket 22-00087, the voting panel in this Docket approved an increase in rates for Superior Wastewater Systems, LLC (SWS) for \$37,838 for recovery of rate case expenses at the monthly rate of \$6.01 per customer. This surcharge was made effective for an 18-month period from September 1, 2023, through February 1, 2025.

Since September 1, 2023, SWS has recovered \$40,170.84 through this surcharge as shown below.
