Petition of Piedmont Natural Gas Company, Inc. (the Company) for Approval of Negotiated Franchise Agreement with Hartsville/Trousdale County, Tennessee pursuant to Tennessee Code Annotated § 65-4-107. The Tennessee Public Utility Commission (TPUC) has scheduled a hearing in the above-captioned Tennessee Code Annotated § 65-4-107 for Tuesday January 17, 2023.
The purpose of the hearing is to consider the petition of the Company seeking approval of the negotiated franchise agreement with the Metropolitan Government of Hartsville/Trousdale County.
This franchise agreement grants the Company the right to construct, operate and maintain a gas utilities system within Metropolitan Hartsville/Trousdale County for production, transmission, distribution, and sale of gas to consumers and users within the Metropolitan Government Limits and any and all agencies and departments thereof. The franchise agreement provides the Metropolitan Government with a franchise fee of 5% of the annual gross revenues from service provided to customers within the geographical boundaries of the Metropolitan Government. The franchise and rights granted shall take effect upon approval of the TPUC and shall continue in force for twenty-five (25) years. The matter has been set for hearing on January 17, 2023.
