Dear Chairman Hilliard:

On December 19, 2022, the West Tennessee Gas Pipeline, LLC ("WTGP" or the "Company") filed *Expedited Petition of West Tennessee Gas Pipeline, LLC for the Issuance of a Certificate of Convenience and Necessity (Petition)* and testimony in support of this *Petition*. In this filing, WTGP is seeking a Certificate of Convenience and Necessity, with its accompanying privilege and franchise, for WTGP to construct, own, and operate a gas pipeline in West Tennessee serving, among others, Ford Motor Company's BlueOval City Project.<sup>1</sup> In the process of opening the docket, the Company conferred with the Consumer Advocate Division of the Tennessee Attorney General's Office ("Consumer Advocate") by sharing information and answered questions related to the project. The Consumer Advocate appreciates WTGP proactively meeting with the Consumer Advocate on more than one occasion so that the Consumer Advocate had sufficient information and time to discuss and review the matter before determining intervention.

The Consumer Advocate has reviewed the *Petition*, the accompanying testimony filed within this docket, and the confidential information provided by WTGP and respectfully expresses its intent not to intervene at this time in this proceeding. The Consumer Advocate's opinion or expression of intent may not be used for any purpose other than the expression of intent not to intervene stated herein.
