ExteNet Telecom Solutions, Inc. (formerly known as Hudson Fiber Network, Inc.)(the "Company") notifies the Commission that the Company's current name is "ExteNet Telecom Solutions, Inc." as a result of a legal name change. Enclosed is a check for \$25.00 for the filing fee.

The Company's amended authorization to transact business is provided as Attachment A. Also attached as Attachment B is the rider to the indemnity agreement reflecting the addition of the Company's name change for its surety bond. The Company requests that the Commission update its records, including the Company's Certificate,¹ to reflect the name change and, to the extent necessary, approve the name change

The Company is not currently serving end user customers in the State of Tennessee, and therefore, does not enclose a proposed notice to Tennessee customers of the name change.

¹ In Tennessee, the Company is authorized to provide competing local exchange and interexchange telecommunications service by an Order issued in Docket No. 19-00087 on December 30, 2019. Since the Company does not provide switched access services, it does not maintain tariffs with the Commission. The Company filed a Notification of Intent to Operate Pursuant to Market Operation on October 15, 2020.

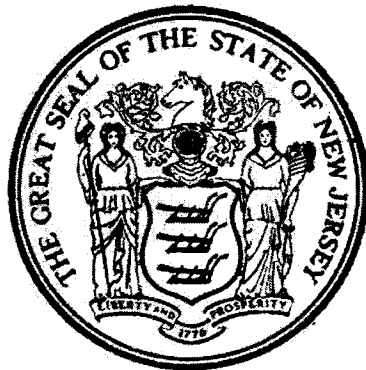
