### ORDER ESTABLISHING PROCEDURAL SCHEDULE

This matter is before the Hearing Officer of the Tennessee Public Utility Commission ("Commission" or "TPUC") to establish a procedural schedule for the orderly administration of these proceedings. At the request of the Hearing Officer, Limestone Water Utility Operating Company, LLC ("Limestone" or the "Company"), DSH & Associates, LLC ("DSH") (together "Joint Petitioners"), and the Consumer Advocate Division of the Office of the Attorney General ("Consumer Advocate"), the parties in this matter, filed the *Joint Filing of Revised Proposed Procedural Schedule* on June 27, 2023. The goal and design of any procedural schedule is to efficiently move the proceedings forward to a hearing and final conclusion on the merits. Nevertheless, a procedural schedule's effectiveness directly depends on cooperation by the parties in meeting the individual benchmark dates. Based on the agreements made by Limestone, DSH, and the Consumer Advocate
