Enclosed for filing in the referenced docket is the original *Petition for Approval of the Amendment to the Interconnection Agreement Negotiated by AT&T Tennessee and CLEC*. As required, included with this filing is the \$50 filing fee made payable to the Tennessee Public Utility Commission.

In accordance with Section 252(e) of the Telecommunications Act of 1996, the Tennessee Public Utility Commission is charged with approving or rejecting the negotiated Amendment between AT&T Tennessee and CLEC within 90 days of its submission. The Act provides that the Tennessee Public Utility Commission may only reject such an amendment if it finds that the amendment or any portion of the amendment discriminates against a telecommunications carrier not a party to the amendment or the implementation of the amendment or any portion of the amendment is not consistent with the public interest, convenience, and necessity. CLEC and AT&T Tennessee aver that the Amendment is consistent with the standards for approval.

This Amendment (1) Adds the state of California; (2) Modifies DS1 and DS3 transport rates; (3) Removes Cincinnati Bell Any Distance, Inc. from the Agreement in various states; (4) Supersedes Cincinnati Bell Any Distance, Inc.'s resale agreements in the various states; (5) Assigns and uses Cincinnati Bell Any Distance, Inc.'s company codes and ACNA to CBTS Technology Solutions LLC and (6) Reflects that the Agreement, in the States of Mississippi and Wisconsin, was filed with the state commission as CBTS Technology Solutions LLC Interconnection Agreement.

AT&T Tennessee respectfully requests that the Commission approve the Amendment to the Agreement.

**PETITION FOR APPROVAL OF THE AMENDMENT TO THE INTERCONNECTION AGREEMENT
NEGOTIATED BETWEEN AT&T TENNESSEE AND CBTS TECHNOLOGY SOLUTIONS, LLC**

AT&T Tennessee ("AT&T") and CBTS Technology Solutions, LLC ("CLEC") file this request for approval of the Amendment to the Interconnection Agreement (the "Agreement") negotiated between the two companies pursuant to Sections 251 and 252 of the Telecommunications Act of 1996 (the "Act"). In support of their request, CLEC and AT&T state the following:

1. CLEC and AT&T have negotiated an agreement for interconnection of their networks, the unbundling of specific network elements offered by AT&T and the resale of AT&T's telecommunications services to CLEC.
2. The parties have recently negotiated an amendment to the Agreement. The amendment (1) Adds the state of California; (2) Modifies DS1 and DS3 transport rates; (3) Removes Cincinnati Bell Any Distance, Inc. from the Agreement in various states; (4) Supersedes Cincinnati Bell Any Distance, Inc.'s resale agreements in the various states; (5) Assigns and uses Cincinnati Bell Any Distance, Inc.'s company codes and ACNA to CBTS Technology Solutions LLC and (6) Reflects that the Agreement, in the States of Mississippi and Wisconsin, was filed with the state commission as CBTS Technology Solutions LLC Interconnection Agreement. A copy of the Amendment is attached hereto and incorporated herein by reference.

3. Pursuant to Section 252(e) of the Telecommunications Act of 1996, CLEC and AT&T are submitting their Agreement to the Tennessee Public Utility Commission for its consideration and approval. In accordance with Section 252(e) of the Act, the Tennessee Public Utility Commission is charged with approving or rejecting the negotiated Amendment to the Agreement between AT&T and CLEC within 90 days of its submission. The Act provides that the Tennessee Public Utility Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience, and necessity.

4. CLEC and AT&T aver that the Agreement is consistent with the standards for approval.

5. Pursuant to 47 USC Section 252(i) and 47 C.F.R. Section 51.809, AT&T shall make available the entire Interconnection Agreement approved pursuant to 47 USC Section 252.

CLEC and AT&T respectfully request that the Tennessee Public Utility Commission approve the Amendment to the Agreement negotiated between the parties.

This Amendment (the "Amendment") amends the Interconnection Agreement by and between BellSouth Telecommunications, LLC d/b/a AT&T ALABAMA, AT&T FLORIDA, AT&T GEORGIA, AT&T KENTUCKY, AT&T LOUISIANA, AT&T MISSISSIPPI, AT&T NORTH CAROLINA, AT&T SOUTH CAROLINA, and AT&T TENNESSEE; Illinois Bell Telephone Company, LLC d/b/a AT&T ILLINOIS; Indiana Bell Telephone Company Incorporated d/b/a AT&T INDIANA; Michigan Bell Telephone Company d/b/a AT&T MICHIGAN; Nevada Bell Telephone Company d/b/a AT&T NEVADA and AT&T Wholesale; The Ohio Bell Telephone Company d/b/a AT&T OHIO; Pacific Bell Telephone Company d/b/a AT&T CALIFORNIA; Southwestern Bell Telephone Company d/b/a AT&T ARKANSAS, AT&T KANSAS, AT&T MISSOURI, AT&T OKLAHOMA, and AT&T TEXAS; and Wisconsin Bell, Inc. d/b/a AT&T WISCONSIN ("AT&T") and CBTS Technology Solutions LLC, CBTS Technology Solutions, LLC, Cincinnati Bell Any Distance, Inc. and Cincinnati Bell Extended Territories LLC, Cincinnati Bell Extended Territories LLC d/b/a altafiber Extended Territories ("CLEC"). AT&T and CLEC are hereinafter referred to collectively as the "Parties" and individually as a "Party".

WHEREAS, AT&T and CLEC are Parties to an Interconnection Agreement under Sections 251 and 252 of the Communications Act of 1934, as amended (the "Act"), signed November 13, 2019 and as subsequently amended (the "Agreement"); and

WHEREAS, the entities operating in each state are outlined in Exhibit C; and

WHEREAS, the Parties desire to amend the Interconnection Agreement to modify certain rates; and

WHEREAS, CBTS Technology Solutions LLC has assumed the OCNs and ACNAs from Cincinnati Bell Any Distance Inc.; and

WHEREAS, CBTS Technology Solutions LLC represents that it has registered these OCNs with NECA; and

WHEREAS, CBTS Technology Solutions LLC represents that it has registered these ACNAs with Telcordia; and

WHEREAS, CBTS Technology Solutions LLC agrees to assume all responsibilities, liabilities, and obligations of Cincinnati Bell Any Distance, Inc.; and

WHEREAS, the Parties desire to supersede Cincinnati Bell Any Distance, Inc.'s resale agreements in the States of Alabama, California, Mississippi, and Wisconsin; and

WHEREAS, the Parties desire to remove Cincinnati Bell Any Distance, Inc. from the Agreement in the States of Alabama, California, Louisiana, Mississippi and Wisconsin; and

WHEREAS, the Parties desire to add the State of California, applicable rates, and attachments to the Agreement for CBTS Technology Solutions LLC; and

WHEREAS, the Parties desire to reflect that the Agreement, in the States of Mississippi and Wisconsin, was filed with the state commission as CBTS Technology Solutions LLC Interconnection Agreement; and

NOW, THEREFORE, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

1. The Amendment is composed of the foregoing recitals and the terms and conditions contained herein, and Pricing Sheets (Exhibit A and Exhibit B), all of which are hereby incorporated by this reference and constitute a part of this Amendment.
2. Wholesale Services Definitions. Wholesale Services provided by AT&T include:
 - a) Interconnection Services such as collocation(s),
 - b) Unbundled Network Elements (UNEs),
 - c) Facilities such as local interconnection trunking and special and switched access services.
 - d) Resale services
 - e) Structure Access and License Agreements,
 - f) Other agreements, including but not limited to inside wire maintenance, transit service and VoIP 9-1-1.
3. Add the Pricing Sheet in Exhibit A. The rates in Exhibit A supersede the rates for the corresponding elements in the Pricing Sheet in the Agreement.
4. To the extent CLEC is no longer purchasing commercial local transport pursuant to a separate agreement using the USOCs and Basic Classes of Services set forth on the Pricing Sheet in Exhibit A, CLEC shall provide Notice to AT&T to implement the rates set forth in Exhibit B. Upon verification that CLEC is no longer purchasing commercial local transport, AT&T will implement the rates in Exhibit B. Depending on CLEC's bill period and AT&T billing system processes, the rate change may take up to two billing cycles to go into effect.
5. The Parties agree to add the State of California to the Agreement for CBTS Technology Solutions LLC; the applicable pricing sheets and state specific appendices, are included in the Agreement.
6. The Parties agree to remove Cincinnati Bell Any Distance, Inc. from the Agreement in the States of Alabama, California, Louisiana, Mississippi, and Wisconsin.
7. The Parties agree to supersede Cincinnati Bell Any Distance, Inc.'s resale agreements in the States of Alabama, California, Mississippi, and Wisconsin.
8. The Parties agree to assign and use Cincinnati Bell Any Distance, Inc.'s company codes and ACNA to CBTS Technology Solutions LLC upon the Effective Date of this Amendment.
9. The Cincinnati Bell Any Distance, Inc. company codes (OCNs) 096G, 118G, 178G, 213G, 245G, 739E, 969F, 971F, 972F, 973F, 9901 and 993F are assigned to CBTS Technology Solutions LLC.
10. The Cincinnati Bell Any Distance, Inc. ACNA CBD is assigned to CBTS Technology Solutions LLC.
11. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
12. This Amendment shall not modify or extend the Effective Date or Term of the underlying Agreement, but rather, shall be coterminous with such Agreement
13. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law, or under the intervening law, or regulatory change provisions, in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
14. This Amendment shall be filed with the applicable State Commissions and will become effective July 12, 2022.
