**JOINT MOTION TO ADOPT REVISED PROCEDURAL SCHEDULE**

Chattanooga Gas Company (“CGC” or “Company”) and the Consumer Advocate Division of the Office of the Tennessee Attorney General (“Consumer Advocate”), hereby submit this joint motion requesting the adoption of a revised procedural schedule and in support hereof state:

1. On May 18, 2023, the Hearing Officer entered the Order Establishing Procedural Schedule in this proceeding, establishing the Procedural Schedule and setting the hearing in this matter for August 14, 2023.
2. The Procedural Schedule contemplates two sets of discovery requests issued by the Consumer Advocate to CGC.
3. The Company has implemented a new accounting system since its previous annual rate review filing in TPUC Docket No. 22-00032. As a result, the parties have engaged in additional discovery and cooperative discussions.


5. With agreement of CGC, the Consumer Advocate has now served four sets of discovery on CGC.

6. In order to accommodate the fourth set of discovery prior to the Consumer Advocate pre-filed testimony deadline in the Procedural Schedule, while still maintaining the August 14, 2023, hearing date, CGC and the Consumer Advocate propose minor revisions to the Procedural Schedule as reflected in **Exhibit A** hereto.

7. The undersigned has conferred with counsel for the Consumer Advocate and is authorized to represent its joinder in this Motion.

WHEREFORE, CGC and the Consumer Advocate respectfully requests that the Commission grant this Joint Motion to Adopt Revised Procedural Schedule.
