6	Q2.	ARE YOU THE SAME JOHN POWELL WHO PRESENTED PRE-FILED
7		DIRECT TESTIMONY IN THIS DOCKET?
8	<i>A2</i> .	Yes.
9		
10	Q3.	WHAT IS THE PURPOSE OF YOUR SUPPLEMENTAL TESTIMONY?
11	<i>A3</i> .	The purpose of my supplemental testimony is to present additional information to
12		the Commission regarding the one-time capital costs that will be charged to the
13		Triune-Area customers that choose to receive monthly wastewater service from
14		Superior Wastewater Systems, LLC ("Superior" or "the Company"). The rates
15		for these one-time capital charges were not available when my direct testimony
16		was filed.
17		
18	Q4.	WHAT ARE THE FORECASTED CAPITAL COSTS TO BUILD THE
19		TRIUNE-AREA WASTEWATER SYSTEM?
20	A4.	As shown in Table 1 below, the Developer's forecast for the capital costs to build
21		a 300,000 gallon per day wastewater system for the Triune-Area will be
22		approximately \$15.5 million.

As mentioned earlier, the wastewater plant is designed with a capacity of 300,000 gallons per day. Therefore, the one-time capital cost charged to each customer is \$51.54 per gallon of capacity as shown below on Table 2.

12 **A6.** The daily capacity for each customer generally comes from the tables published 13 by the Tennessee Department of Environment and Conservation ("TDEC") and 14 are included here as Supplemental Exhibit 2. For residential customers, which

1		will represent most of the daily usage, the estimated capacity is 300 gallons per
2		day. For commercial customers, the daily capacity is dependent on the unique
3		usage requirements for each customer.

5	Q7.	WHAT OTHER COSTS WILL BE CHARGED TO TRIUNE-AREA
6		CUSTOMERS?
7	A7.	In addition to the Capital Costs described above, residential customers will also
8		need to install a wastewater collection tank on their premises. Finally, all
9		customers will be required to pay an allocated share of the Williamson County
10		Bonding Costs.
11		
12	<i>Q8.</i>	PLEASE EXPLAIN THE COSTS RELATED TO THE WASTEWATER
13		COLLECTION TANK FOR RESIDENTIAL CUSTOMERS.
14	<i>A8</i> .	A 1,750-gallon underground wastewater collection tank is required for residential
15		installations to help reduce the amount of sludge in the processing facility. This
16		type of tank is identical to the ones installed on each lot at Kings Chapel
17		Subdivision. The cost for these tanks varies, but currently runs about \$6,700.
18		
19	Q9.	PLEASE EXPLAIN THE WILLIAMSON COUNTY BONDING COSTS
20		THAT ARE CHARGED TO ALL CUSTOMERS.
21	A9.	Williamson County requires a 30% bond on the construction costs (excluding
22		land costs and internal labor) of the wastewater system that is applied to each
23		Phase of construction. As shown in Table 3 below, the base construction-only

forecasted capital costs are expected to be approximately \$5.1 million. When this cost is applied to the bond percentage and the allocated capacity percentage, the expected bond charge for a residential customer in Phase 1 of construction will be \$508. This bond cost is eventually refunded to the customer when construction has been completed and the bond is released by Williamson County.

6 Q10. CAN YOU PROVIDE AN EXAMPLE FOR HOW THE TOTAL CAPITAL 7 COST FOR A RESIDENTIAL CUSTOMER IS COMPUTED?

Yes. First, as shown below on Table 4, the residential customer capacity of 300 gallons per day is multiplied by the Capacity Charge of \$51.54 to produce a one-time capital surcharge to the customer of \$15,462. Next the \$6,700 cost for the wastewater collection tank and the \$508 cost for the Williamson County Bonding Charge are included which brings the total installed cost to \$22,670 for a residential customer.



The Capital Surcharge is nonrefundable and must be paid before monthly wastewater service can begin.

Residential customers are required to have a Wastewater Collection Tank installed at their premises of sufficient quality and construction to the Company's satisfaction. The current cost for these tanks is approximately \$6,700, but this cost can vary over time. The Wastewater Collection Tank must be installed and paid for before wastewater service can begin.

1 2		Williamson County requires a separate bonding charge on the construction of wastewater systems. This bonding charge is fully refundable to the customer when
3		construction has been completed and the bond is released by Williamson County.
4		The bonding charge for each customer is based on each customer's daily capacity
5		as a percentage of the total daily capacity available and must be paid before
6		monthly service can begin.
7		Although the capital cost for the Triune-Area wastewater system is not rate
8		regulated by the Commission, I believe that including the language shown above
9		in the tariff helps provide transparency for the customer over how their capital
10		charges are calculated.
11		
12	Q12.	DOES THIS COMPLETE YOUR SUPPLEMENTAL TESTIMONY?
13	A12.	Yes, it does.
