Dear Chairman:

This letter is submitted on behalf of Network Telephone, LLC d/b/a Paetec Business Services and d/b/a Cavalier Business Communications ("Network Telephone") to notify the Tennessee Public Utility Commission ("Commission") of its name change. Network Telephone has discontinued use of the fictitious names "Paetec Business Services" and "Cavalier Business Communications". Going forward Network Telephone will operate using the name "Network Telephone, LLC". Network Telephone is authorized to operate as a facilities-based local exchange and resold interexchange service provider, pursuant to certification granted in Docket Nos. 00-00009 and 98-00349.

This change will have no effect on customers who will continue to receive service without interruption under the name Network Telephone, LLC.

Network Telephone respectfully requests the Commission to update its records accordingly to reflect its new name, Network Telephone, LLC.

As illustrated in the attached Exhibit 1, PAETEC Business Services was cancelled effective April 5, 2016, and Cavalier Business Communications expired effective January 22, 2012.





RESOLVED, that the signature of any authorized officer and the seal of the Company may be affixed by facsimile to any power of attorney or certification thereof authorizing the execution and delivery of any bond, undertaking, recognizance, or other suretyship obligation of the Company; and such signature and seal when so used shall have the same force and effect as though manually affixed. The Company may continue to use for the purposes herein stated the facsimile signature of any person or persons who shall have been such officer or officers of the Company, notwithstanding the fact that they may have ceased to be such at the time when such instruments shall be issued.
