Revised Notice is hereby given that Atmos Energy Corporation (the Company) filed a Petition with the Tennessee Public Utility Commission (TPUC) on September 8. 2023 in Docket 23-00068, seeking approval pursuant to Tenn. Code Ann. 65-4-107 of a new franchise agreement with the Town of Greeneville (Town). This franchise agreement grants the Company the non-exclusive rights, authority, privilege and franchise to erect, construct, reconstruct, maintain and operate a natural gas plant or plants for the manufacturing and processing of any and all kinds of gas and for the distribution of natural gas and for the installation and maintenance of mains pipes, pipelines, distribution lines, and other equipment necessary or incidental to distribution of said gas upon, across, along and under the highways, streets, avenues roads ,alleys, lanes and other public grounds of the Town. Rates for residential customers will be unaffected by this franchise agreement, although commercial and industrial customers' rates will increase by approximately \$2.73 per month for commercial and approximately \$19.00 per month for industrial customers to reflect a change in the franchise fee, which will be increased from 2% to 3% of the Company's Revenues within the Town. A complete copy of the Company's filing is on file with the TPUC and is open for public inspection. The franchise and the rights granted shall take effect upon approval of the Tennessee Public Utility Commission and shall continue in force for a term of twenty (20) years. During each year of the term hereof, the Company shall collect from its customers within the Town of Greeneville a franchise fee in an amount of 3% of Company's Revenues within the Town, as defined in the franchise agreement. Said franchise fee shall be paid quarterly to the Town of Greeneville with each payment due and payable within thirty (30) days from the end of the quarter for which payment is due, so long as the Company shall supply and sell natural gas to the public within said Town, or so long as this franchise is in effect. The matter has been scheduled for hearing and will be heard on November 6, 2023 beginning at 10:00 a.m. CST in the TPUC's hearing room on the ground floor of the Andrew Jackson State Office Building at 500 Deaderick Street, Nashville, Tennessee
