PETITION FOR transfer of 2-1-1 designation for East and Upper East Tennessee

United Way of Greater Knoxville - East Tennessee 211 ("Petitioner") respectfully submits this Petition for 2-1-1 designation for the purpose of providing health and human services information and referral to citizens in Anderson, Blount, Campbell, Carter, Claiborne, Cocke, Greene, Grainger, Hancock, Hawkins, Jefferson, Johnson, Knox, Loudon, Monroe, Morgan, Roane, Scott, Sullivan, Sevier, Unicoi, Union, and Washington counties.

#### **INTRODUCTION**

- Petitioner is the current 2-1-1 provider for the 16-county East Tennessee Region and the 8 County Northeast Tennessee Region with its place of business is in Knoxville, TN.
- 2. East Tennessee 211 is a member of Inform TN (FORMERLY TN AIRS) and receives funding from area United Ways, COORDINATED BY United Way of Greater Knoxville. East Tennessee 211 and 211 Northeast have been in operation for 20 years and our program was the third in the US to go live. (98+% of the US has coverage today). Calls for the counties listed will continue to receive the same high-quality service, from the same call center, that they do today.

#### **DESIGNATION SOUGHT**

3. Petitioner seeks designation for 2-1-1 in the counties listed above under United Way of Greater Knoxville (UWGK) and removal of the Knoxville/Knox County Community Action Committee (CAC). This area is referred to collectively as East Tennessee 211.

#### **STANDARD FOR GRANT OF PETITION**

The petition for 2-1-1 designation in Anderson, Blount, Campbell, Carter, Claiborne, Cocke, Greene, Grainger, Hancock, Hawkins, Jefferson, Johnson, Knox, Loudon, Monroe, Morgan, Roane, Scott, Sullivan, Sevier, Unicoi, Union, and Washington counties is part of the Inform TN (Formerly TN AIRS) plan for statewide coverage. CAC has agreed to transition 2-1-1 designation in East Tennessee to United Way of Greater Knoxville.

#### **REASONS SUPPORTING DESIGNATION AS 2-1-1 COLLABORATIVE**

- 4. In support of this Amended Petition, Petitioner would show as follows:
  - a. Financial status: East Tennessee 211 has been answering calls and inquiries since July 2001. Funding is received from area United Ways, government grants, and other community partners and is coordinated by United Way of Greater Knoxville. UWGK continues its commitment to funding 2-1-1 and maintaining sustainability. This change only serves to streamline budget and operating processes.
  - b. Technical ability: East Tennessee 211 already provides 2-1-1 service to all 23 counties listed, is a member of Inform TN, the Director is a member of the National 2-1-1 Steering Committee, and the organization remains committed to highest levels of service. Our call center has been recognized several times on a national level for our service to the community, having recently received an AIRS award for collaboration for work with partner agencies during the COVID-19 pandemic, in particular for our work connecting callers with access to rent, mortgage, and utility assistance through Knox County's Federal Treasury Grant. Area government, area United Ways, and the Community Action Committee of Knox County support this petition. Our office has made enhanced services available including an already operational chatbot, live chat, web intake forms, and social media contact and support. East Tennessee 2-1-1 has a relationship with the University of Tennessee's School of Social Work and regularly employs 1-2 interns throughout the year, some undergrad, and some master's candidates. East Tennessee has Inform TN certified operators answering all 2-1-1 calls for Information & Referral. East Tennessee 2-1-1 also has a modern ACD phone system as well as call recording and live monitoring for quality assurance. Russ Jensen, Inform TN President and East Tennessee 211 Director, will be responsible for ongoing services in the petitioned counties. East Tennessee 211 will be responsible for adding resources from the petitioned counties to their database of health and human services in the WellSky software program that is currently in use. East Tennessee 211 participates with local EMA offices as well as Region 2, Homeland Security on disaster preparedness and recovery.

c. Managerial capability: Russ Jensen is the Director of East Tennessee 211 and the President of Inform Tennessee. He was on the board for the original 211 for East Tennessee when it went live in 2000-2001.

### CONCLUSION

5. Petitioner respectfully requests that the Tennessee Public Utility Commission approves this request to assign n-1-1 (2-1-1) designation for the above listed counties. Calls to the 2-1-1 will continue to be answered in the same call center they are today.
