The Tennessee Public Utility Commission ("Commission" or "TPUC") is seeking comment from members of the public regarding the Petition for a general rate increase filed on July 16, 2024, by Limestone Water Utility Operating Company, LLC.

The Commission will hold a public meeting in Counce, Tennessee on **Thursday, January 30, 2025, from 3:00 p.m. (CST) to 6:00 p.m. (CST)** at The Lodge at Pickwick Landing State Park, Conference C-C1 located at 120 Playground Loop, Counce, TN 38326. Commissioner Herbert H. Hilliard will preside over the public meeting, and members of the public are invited to attend and present comments. The Commission will hear testimony from witnesses during a public hearing in Nashville in Hearing Room G.201, Andrew Jackson State Office Building, 500 Deaderick Street, Nashville, Tennessee beginning on February 18, 2025, at 10:00 a.m. (CST) to determine whether the requested rate increase, or any part thereof, should be approved. The public will have an opportunity to offer comments during the hearing as well.
