Please review the attached spread sheet to visually see how dramatic the financial implication of the Limestone proposed water and sewer rates would be for my wife and I. This attached spread sheet displays my personal Limestone service charges for this past year compared to what the charges would be per their requested rate if you were to approve. You will note that for the exact same volume of consumption my water cost would increase from \$297 to \$818 and the sewer service fee would increase from \$297 to \$1040 resulting in an overall increase of 213% or \$1264. In my opinion, this is not a fair and reasonable increase. I hope you do as well.

Your thoughtful consideration of this matter would be greatly appreciated by me and some 350 of my neighbors.
