## **NOTICE OF FILING AND PENDING CLOSURE OF DOCKET**

**TO:** Docket File No. 24-00046

**IN RE:** *Petition of GO MD USA LLC for Designation as an Eligible Telecommunications Carrier in the State of Tennessee for the Limited Purpose of Providing Lifeline Service to Qualifying Customers*

On July 22, 2024, GO MD USA LLC (“Company”) filed a *Petition for Designation as an Eligible Telecommunications Carrier in the State of Tennessee for the Limited Purpose of Providing Lifeline Service to Qualifying Customers* (“Petition”). On July 31, 2024, the Commission’s advisory staff (Staff) sent its first data request to the Company. The data request states, “[p]lease provide the information requested on or before August 31, 2024. If this information is not provided by this date, this docket may be subject to dismissal.”<sup>1</sup> A request for additional information was later sent to the Company on August 20, 2024, with responses to the Staff’s requests due on or before September 6, 2024.<sup>2</sup> Subsequently, the Company requested a one-week extension of time to produce responses to the data requests. Staff agreed to the extension, indicating that responses would be due on September 13, 2024.<sup>3</sup> To date, substantive responses to the Staff’s requests for information have not been filed with the Commission.


