Pursuant to applicable Tennessee Statues and the Rules and Regulations of the Tennessee Regulatory Authority and Section 253 of the Federal Telecommunications Act of 1996 ("Act"), Ripple Fiber Tennessee LLC ("Ripple Fiber") respectfully requests that the Tennessee Regulatory Authority ("TRA") grant to Ripple Fiber authority to provide competing local telecommunications services, including exchange access telecommunications services, within the State of Tennessee. Ripple Fiber is willing and able to comply with all applicable rules and regulations in Tennessee pertaining to the provision of competing local telecommunications services. TCA 65-4-201

3. <u>Corporate information</u>:

Ripple Fiber's Articles of Incorporated in the state of Delaware on May 20, 2024. A copy of Ripple Fiber's Articles of Incorporation and amendments are provided in **Exhibit B**. A copy of Ripple Fiber's Authority to transact business in the State of Tennessee is provided in **Exhibit C**. The names and addresses of the principal corporate officers are in **Exhibit D**. There are no officers in Tennessee. The biographies of the principal officers and any other key technical staff are in **Exhibit E**.

4. <u>Ripple Fiber possesses the managerial, technical, and financial ability to provide</u> local telecommunications service in the State of Tennessee as demonstrated below:

A. Financial Qualifications:

In support of its financial qualifications, Ripple Fiber submits the year-end 2023 Income Statement, Balance Sheet, and Cash Flow Statement in Confidential **Exhibit F**.

Exhibit F summarizes the recent financial performance of the parent company Ripple Fiber LLC. These include income statements, balance sheets, and statement of cash flows for year-end 2023. Thus, Ripple Fiber asserts that it has the financial resources necessary to operate as a competitive local service provider in Tennessee.

Ripple will own and operate equipment facilities in Tennessee with a value of more than \$5,000,000 and are therefore exempt from the corporate surety bond requirement.

B. Managerial Ability:

As shown in **Exhibit E** to this Application, Ripple Fiber has the managerial expertise to successfully operate a telecommunications enterprise in Tennessee. As described in the attached biographical information, Ripple Fiber's management team has extensive management and business experience in telecommunications.

C. Technical Qualifications:

Ripple Fiber services will satisfy the minimum standards established by the TRA. The company will file and maintain tariffs in the manner prescribed by the TRA and will meet minimum basic local standards, including quality of service and billing standards required of all LEC'S regulated by the TRA. Applicant will not require customers to purchase CPE, which cannot be used with the Incumbent Local Exchange Carrier's systems. As noted in the biographies **Exhibit E** of the principal officers, there are two officers with engineering backgrounds and several years of telecommunications expertise. Thus, Ripple Fiber is certainly technically qualified to provide local exchange service in Tennessee.

5. <u>Proposed Service Area:</u>

Ripple Fiber is already authorized to provide telecommunications services in North Carolina, South Carolina, Georgia and Michigan. Additionally, Ripple Fiber has pending applications for authority in California, New Mexico, Illinois and Massachusetts. Ripple Fiber intends to offer services statewide in Tennessee, to the extent open to competition.

6. Types of Local Exchange Service to be provided:

Ripple Fiber plans to offer facilities based and resold local exchange services and unregulated services to both residential customers and business customers. Those services will be provided via (1) Ripple's own facilities, (2) commercial wholesale agreements with incumbents, or (3) a combination thereof. The facilities based regulated and unregulated services will include, but not be limited to; local exchange and extended area service, toll restriction, caller ID services, telephone number porting, E-911 emergency services, operator services, private line and special access services, broadband services, and transport services.

7. Repair and Maintenance:

Ripple Fiber understands the importance of effective customer service for local service customers. Ripple Fiber has made arrangements for its customers to call the company at its toll-free customer service number 1-800-359-5767. In addition, customers may contact the company in writing at the headquarters address, as well as via email at support@ripplefiber.com. The toll free number will be printed on the customer's monthly billing statements. The Tennessee contact person knowledgeable about providers operations is Mike Banda, Director of Customer Experience, referenced in Exhibit E.

Grant of the Application will further the goals of the Tennessee Legislature and further the public interest by expanding the availability of competitive telecommunications services in the State of Tennessee. In addition, intrastate offering of these services is in the public interest because the services will provide Tennessee customers increased efficiencies and cost savings. Authorizing Ripple Fiber to provide local exchange telecommunications services will enhance materially the telecommunications infrastructure in the State of Tennessee and will facilitate economic development.

In particular, the public will benefit both directly, through the use of the competitive services to be offered by Ripple Fiber and indirectly, because Ripple Fiber's presence in Tennessee will increase the incentives for other telecommunications providers to operate more efficiently, offer more innovative services, reduce their prices, and improve their quality of service. Grant of this Application will further enhance the service options available to Tennessee citizens for the reasons set forth above.

For the reasons stated above, Ripple Fiber's provision of these services would promote the public interest by providing high-quality service at competitive prices and by creating greater economic incentives for the development and improvement for all competing providers.





Pursuant to T.C.A. §65-5-112, as amended, Ripple Fiber Tennessee LLC ("Ripple Fiber") submits this small and minority-owned Telecommunications business participation plan (the "Plan") along with its Application for a Certificate of Public Convenience and Necessity to provide competing intrastate and local exchange services in Tennessee.

I. PURPOSE

The purpose of §65-5-112 is to provide opportunities for small and minority-owned businesses to provide goods and services to Telecommunications service providers. Ripple Fiber is committed to the goals of §65-5-112 and to taking steps to support the participation of small and minority-owned Telecommunications businesses in the Telecommunications industry. Ripple Fiber will endeavor to provide opportunities for small and minority-owned Telecommunications businesses to compete for contracts and subcontracts for goods and services. As part of its procurement process, Ripple Fiber will make efforts to identify and inform minority-owned and small businesses that are qualified and capable of providing goods and services to Ripple Fiber of such opportunities. Ripple Fiber's representatives have already contacted the Department of Economic and Community Development, the administrator of the small and minority-owned Telecommunications assistance program, to obtain a list of qualified vendors. Moreover, Ripple Fiber will seek to increase awareness of such opportunities so that companies not otherwise identified will have sufficient information to participate in the procurement process.

II. **DEFINITIONS**

As defined in §65-5-112.

Minority-Owned Business. Minority-owned business shall mean a business which is solely owned, or at lease fifty-one percent (51%) of the assets or outstanding stock of which is owned, by an individual who personally manages and controls daily operations of such business, and who

is impeded from normal entry into the economic mainstream because of race, religion, sex or national origin and such business has annual gross receipts of less than four million dollars (\$4,000,000).

Small Business. Small Business shall mean a business with annual gross receipts of less than four million dollars (\$4,000,000).

III. ADMINISTRATION

Ripple Fiber's Plan will be overseen and administered by the individual named below, hereinafter referred to as the Administrator, who will be responsible for carrying out and promoting Ripple Fiber's full efforts to provide equal opportunities for small and minority-owned businesses.

The Administrator of the Plan will be:

The Administrator's responsibilities will include:

- (1) Maintaining an updated Plan in full compliance with §65-5-112 and the rules and orders of the Tennessee Regulatory Authority.
- (2) Establishing and developing policies and procedures necessary for the successful implementation of the Plan.
- (3) Preparing and submitting such forms as may be required by the Tennessee Regulatory Authority, including the filing of required annual updates.
- (4) Serving as the primary liaison to and cooperate with the Tennessee Regulatory Authority, other agencies of the State of Tennessee, and small and minority-owned businesses to locate and use qualified small and minority-owned businesses as defined in §65-5-112.

- (5) Searching for and developing opportunities to use small and minority-owned businesses and encouraging such businesses to participate in and bid on contracts and subcontracts.
- (6) Providing records and reports and cooperating in any authorized surveys as required by the Tennessee Regulatory Authority.
- (7) Establishing a record-keeping system to track qualified small and minority-owned businesses and efforts to use such businesses.
- (8) Providing information and educational activities to persons within Ripple Fiber and training such persons to seek out, encourage, and promote the use of small and minority-owned businesses.

In performance of these duties, the Administrator will utilize a number of resources, including:

The Tennessee Department of Economic and Community Development

The United States Department of Commerce

Small Business Administration

Office of Minority Business

The National Minority Supplier Development Counsel

The National Association of Women Business Owners

The National Association of Minority Contractors

Historically Black Colleges, Universities, and Minority Institutions

The efforts to promote and ensure equal opportunities for small and minority-owned businesses are primarily spelled out in the Administrator's duties above. Additional efforts to provide opportunities to small and minority-owned businesses will include offering, where appropriate and feasible, small and minority-owned businesses assistance with technical, insurance, bonding, licensing, production, and deadline requirements.

IV. RECORDS AND COMPLIANCE REPORTS

Ripple Fiber will maintain records of qualified small and minority-owned business and efforts to use the goods and services of such businesses. In addition, Ripple Fiber will maintain records of educational and training activities conducted or attended and of the internal procurement procedures adopted to support this plan.
