- 2 A. My name is Carlos Black. My business address is 502 Deaderick Street, 4th Floor,
- 3 Nashville, Tennessee.
- 4 O. BY WHOM ARE YOU EMPLOYED AND IN WHAT CAPACITY?
- 5 A. I am employed by the Tennessee Public Utility Commission ("Commission" or "TPUC").
- 6 My title is Utility Rate Specialist.
- 7 Q. DO YOUR RESPONSIBILITIES AT THE TENNESSEE PUBLIC UTILITY
- 8 COMMISSION INCLUDE DUTIES RELATED TO SMALL AND MINORITY-OWNED
- 9 TELECOMMUNICATIONS BUSINESS PLAN ("SMBP Plan") FILINGS FROM
- 10 PROVIDERS OF TELECOMMUNICATIONS SERVICES?
- 11 A. Yes. I receive the annual SMBP Plan filings required by Tenn. Code Ann. § 65-5-112. I
- 12 ensure that regulated providers of telecommunications services in Tennessee have submitted the
- annual filing required by law. I send reminder letters as the due date for the filing approaches and
- where a regulated utility has not timely submitted the annual filing, I make contact with Company
- representatives in an attempt to obtain compliance.

- 16 Q. IN THE COURSE OF YOUR DUTIES RELATED TO SMBP PLAN FILINGS,
- 17 HAVE YOU HAD ANY INTERACTIONS WITH COMTECH 21, LLC ("Comtech 21" or
- 18 "Company")?
- 19 A. Yes. Comtech 21 did not submit the required annual filing relating to its SMBP plan on or
- before April 30, 2024 as required. On April 1, 2024, prior to the deadline, I sent a reminder letter
- 21 to Comtech 21 to the address provided to the Commission requesting the Company submit its
- 22 annual SMBP Plan filing. After the deadline for filing had passed, I attempted to call a Company
- 23 Representative of Comtech 21 on two (2) occasions. I was unsuccessful in reaching the Company
- Representative, but left voicemail messages for the representative on May 21, 2024 and June 26,
- 25 2024. I sent a follow up letter to the Company requesting the annual SMBP Plan filing on July 3,
- 26 2024.
- Q. WHAT, IF ANYTHING, HAS BEEN THE RESPONSE FROM COMTECH 21?
- 28 A. Comtech 21 has not responded to the letters or to either voicemail message. The
- 29 Commission has had no contact with Comtech 21 or any representative of the Company.
- 30 Q. HAS COMTECH 21 COMPLIED WITH THE ANNUAL REQUIREMENT TO
- 31 FILE INFORMATION CONCERNING ITS SMBP PLAN?
- 32 A. No. The Tennessee Public Utility Commission has not received any documentation from
- Comtech 21 that would satisfy its annual SMBP plan filing requirement.
