ORDER GRANTING MOTION TO DISMISS SHOW CAUSE ORDER

This matter is before the Administrative Judge of the Tennessee Public Utility Commission ("Commission" or "TPUC") upon the *Motion to Dismiss Show Cause Order* ("*Motion*") filed by the Tennessee Public Utility Commission Staff as a Party ("Party Staff") on March 10, 2025. In its *Motion*, Party Staff states that after the issuance of the *Order Requiring Comtech 21*, *LLC to Appear and Show Cause* ("*Show Cause Order*"), Party Staff filed in TPUC Docket No. 00-00732 a *Request for Cancellation for Noncompliance* alleging that Comtech 21, LLC ("Comtech" or "Company") failed to file its statutorily required Form UD-16 and annual inspection fee. The Commission found that Comtech was noncompliant with the statutory annual inspection fee requirement and voted to cancel the Company's Certificate for Public Convenience and Necessity. As a result of the *Revocation Order*, Party Staff asserts that it no longer desires to prosecute the *Show Cause Order* and that the subject of requiring Comtech to file a small and minority-owned telecommunications business participation plan filing is now moot. The Administrative Judge finds that Party Staff's *Motion* is well-taken and should be granted.

IT IS THEREFORE ORDERED THAT:

The *Motion to Dismiss Show Cause Order* filed by the Tennessee Public Utility Commission Staff as a Party is granted, the *Order Requiring Comtech 21, LLC to Appear and Show Cause* is
