## WIRELINE COMPETITION BUREAU APPROVES THE AMENDED COMPLIANCE PLAN OF TAG MOBILE, LLC

WC Docket Nos. 09-197 and 11-42

The Wireline Competition Bureau (Bureau) hereby approves the amended compliance plan<sup>1</sup> of TAG Mobile, LLC (TAG) filed pursuant to the requirements for the continued provision of Lifeline service.<sup>2</sup>

The Act provides that a carrier be designated as an eligible telecommunications carrier (ETC) to receive universal service support.<sup>3</sup> The Commission has required that all non-facilities based telecommunications carriers seeking Lifeline-only ETC designation must meet the following conditions: (1) compliance with certain 911 and enhanced 911 (E911) public safety requirements; and (2) Bureau approval of a compliance plan providing specific information regarding the carrier and its service offerings and outlining the measures the carrier will take to implement its obligations.<sup>4</sup>

Any transfer of ownership or control of an ETC with an approved Lifeline compliance plan requires approval of an amended compliance plan in advance of the transaction.<sup>5</sup> This includes renewing compliance plan approval for changes in the corporate structure of the ETC.<sup>6</sup>

In accordance with this requirement, TAG submitted an amended compliance plan to reflect the proposed change in ownership structure of TAG resulting from its purchase out of bankruptcy by Softel Holdings, LLC (Softel)<sup>7</sup> and to otherwise update TAG's Compliance Plan to describe the measures TAG has implemented to comply with the rules and regulations of the Commission governing the provision of

prepaid wireless Lifeline services since TAG's original Compliance Plan was previously approved.<sup>8</sup> TAG is a Lifeline ETC in nineteen states.<sup>9</sup> As approved by TAG's bankruptcy trustee, Softel will acquire one hundred percent of the membership interests of TAG after the transaction closes.<sup>10</sup> Softel is a Texas limited liability company controlled by Henry Do, and Mr. Do also operates several other service providers that participate in the Commission's low-income programs.<sup>11</sup>

The Bureau has reviewed TAG's amended compliance plan for conformance with the relevant requirements and now approves the Amended Compliance Plan. We note that with respect to this matter, TAG will remain the only entity with an approved compliance plan. Additionally, TAG must continue to comply with any future additions to or amendments of the Lifeline program rules unless it has relinquished its relevant designation(s) pursuant to section 214(e)(4) of the Act. <sup>12</sup>

TAG Mobility, LLC d/b/a TAG Mobile satisfies each of the below listed requirements:

- Section 254(e) of the Act provides that, "only an eligible telecommunications carrier designated under section 214(e) shall be eligible to receive specific federal universal service support."
- Section 214(e)(2) of the Act authorizes state commissions, such as the Tennessee Public Utility Commission ("Commission"), to designate ETC status for federal universal service purposes and authorizes the Commission to designate wireless ETCs.
- Section 214(e)(1) of the Act and Section 54.201(d) of the FCC's rules provide that applicants for ETC designation must be common carriers that shall, throughout the designated service area, offer all of the services supported by universal service, either using their own facilities or a combination of their own facilities and the resale of another requirement.

Applicants must also commit to advertise the rates if such services.
