ORDER ACKNOWLEDGING QUALIFICATION TO SERVE CONTIGUOUS TERRITORY

This matter is before the Administrative Judge of the Tennessee Public Utility Commission (“Commission” or “TPUC”) to consider the Notice regarding extension of service to a contiguous territory (“Notice”) filed on November 8, 2024, by Integrated Resource Management Company, Inc. (“IRM”) pursuant to Commission Rule 1220-04-01-.13. Specifically, IRM’s Notice is to extend its wastewater system at Flat Hollow Subdivision to provide service to an additional lot located at 176 Flat Hollow Marina Road, Speedwell Tennessee in Campbell County, Tennessee. IRM is authorized to provide wastewater service to the Flat Hollow Subdivision and maintains this additional lot is contiguous to its current service area. Based on the Notice and the entire record in this matter, the Administrative Judge makes the following findings of fact and conclusions of law.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. IRM was granted a certificate of public convenience and necessity (“CCN”) by the Commission to provide wastewater service to the Flat Hollow subdivision.

2. It appears that 176 Flat Hollow Marina Road is adjacent to the IRM collection line and in the Flat Hollow subdivision and thus is contiguous.

3. IRM has substantially complied with the provisions of Commission Rule 1220-04-01-.13.

IT IS THEREFORE ORDERED THAT:

1. The contiguous extension of service to parcel 079O B 002.00 located at 176 Flat Hollow Marina Road Speedwell Tennessee in Campbell County, Tennessee, is recognized as meeting the Commission's criteria for the extension contingent on Limestone Water Utility Company, LLC filing the following in the docket file:

Pursuant to Commission Rule 1220-04-01-.13(2)(b), file proof that the contiguous territory is not in the service territory of another utility providing similar services.

2. If the documentation is not filed within six (6) months of this order, then Integrated Resource Management Company, Inc. is directed to file a report on the status of the filing of the required documentation. The compliance report shall be updated every three (3) months until all required information has been filed.
