**Re: Notification Regarding the Name Change of ENA Services, LLC to Zayo Education, LLC**

ENA Services, LLC (to be known as Zayo Education, LLC) (the "Company") hereby notifies the Commission that the Company plans to change its legal name to "Zayo Education, LLC," which is expected to take effect beginning January 1, 2025. Enclosed is a check for \$25.00 to cover the filing fee.

The name change is being made to better align the business under the "Zayo" brand name. In Tennessee, the Company is authorized to provide competitive local telecommunications services, including exchange access telecommunications services, and facilities-based and resold interexchange telecommunications services pursuant to a Certificate granted in Docket No. 06-00131 on August 24, 2006. The Company requests that the Commission update its records, including the Company's Certificate, to reflect the name change and, to the extent necessary approve the name change.

Provided as **Attachment A** is the notice language sent to customers regarding the Company's name change. The Company is updating its name with the Tennessee Secretary of State and, once received, the Company will supplement this Notification with its amended authorization to transact business in Tennessee. The updated legal name will also be recorded in any surety bond or letter of credit obtained pursuant to Tenn. Code Ann. § 65-4-125.
