

PUBLIC PAY TELEPHONE SERVICE IN TENNESSEE**



IT IS THEREFORE ORDERED THAT:


1. The company's authority to provide public pay telephone service in Tennessee is hereby reinstated; and

IT IS THEREFORE ORDERED:


- 1) That the request of **American Telephone Exchange** to cancel authority to provide COCOT services in Tennessee, is hereby granted; and
