(hereinafter "IXC-CSI"), hereby requests the Tennessee Regulatory Authority ("Authority") to amend its certification to reflect its change of name. The name change occurred on June 16, 1998. On June 26, 1998, IXC-CSI and Switched Services Communications, L.L.C. ("SSC") sent an application to the Authority regarding the proposed merger of SSC into IXC-CSI. The

merger application also informed the Authority of IXC-CSI's name change.

Enclosed is IXC-CSI's amended Certificate of Authority as filed with the Tennessee Secretary of State.
