Pursuant to the Status Conference conducted in this proceeding, the parties hereby stipulate and agree to the following procedural ground rules and schedule for this matter to be conducted before the Tennessee Regulatory Authority:

PROCEDURAL GROUND RULES:

- (1) That the Tennessee Regulatory Authority has indicated that it will close Docket No. 96-00067 and will open a new docket to consider this matter, namely, "The Avoidable Cost of Providing Bundled Services for Resale by Local Exchange Telephone Companies". That to the extent that items in the closed docket are relevant and useful, all parties must re-submit and re-file them under the new docket.
- (2) That all parties, including those parties who participated in the status conference on August 28, 1996, shall file petitions to intervene by 12:00 noon on September 9, 1996. Such petitions shall contain language indicating that the party agrees to be bound by the Agreed Order and the Protective Order.
- (3) That all filings in this docket shall be made by 12:00 noon and all filings pursuant to this Agreed Order shall be served the same day upon parties either by hand-delivery if such parties are in the same location as the serving party or by serving the document by facsimile transmission if the party is not in the same location as the party serving the document, provided,

however, the Authority shall retain the discretion to make service via regular mail.

- Any party that files an avoided cost study shall, at a minimum, prepare and submit a cost study or model based upon the definition of "avoided costs" found in the applicable sections regulations pertaining and thereto of the Federal Telecommunications Act of 1996 and may submit a cost study or model based upon the rebuttable presumptions also found in the applicable sections and regulations pertaining thereto of the Federal Telecommunications Act of 1996. In so doing, the submitting party is expected to state the rebuttable presumptions upon which the "alternative" study is based.
- (5) The parties to this proceeding, by affixing their signatures hereto, expressly stipulate and agree that they will abide by the procedural ground rules and schedule.

SCHEDULE:

- (6) SEPTEMBER 3, 1996 -- On or before 12:00 noon, all motions for Protective Order must be filed.
- (7) SEPTEMBER 5, 1996 -- At approximately 12:00 noon, the Tennessee Regulatory Authority will act upon any pending motions for protective order.
- (8) SEPTEMBER 9, 1996 -- On or before 12:00 noon, all Petitions to Intervene must be filed.
- (9) SEPTEMBER 10, 1996 -- Any party choosing to file direct testimony shall, on or before 12:00 noon, pre-file such direct

testimony. Any party desiring to introduce a cost study in this proceeding should do so as a part of filing their direct testimony and must also include with the cost study workpapers in support thereof.

- (10) SEPTEMBER 12, 1996 -- On or before 12:00 noon, all discovery requests must be served upon the other parties. The discovery request shall be limited to fifteen (15) in number per party to the opposing party and shall be reasonable in scope provided, however, the Authority shall not be bound by such limits.
- (11) SEPTEMBER 17, 1996 -- On or before 12:00 noon, all responses to discovery filed pursuant hereto shall be served.

Parties may file motions to compel responses to discovery provided such motions (1) state the grounds therefor with specificity and (2) such motions are filed within five (5) days after discovery responses are filed. Parties against whom a motion to compel is filed shall have five (5) days from their receipt of the motion to compel to respond.

- (12) SEPTEMBER 20, 1996 -- On or before 12:00 noon, all parties desiring to file rebuttal testimony must do so.
- (13) SEPTEMBER 30, 1996 -- Beginning at 9:00 AM, the hearing will take place in this matter and will continue, if necessary, at 9:00 AM on October 1, 1996.
