ORDER


This matter is before the Tennessee Regulatory Authority ("Authority") upon the petition of Buehner-Fry, Inc. to change its company name. The Authority considered this request at an Authority Conference held on March 4, 1997, and concluded that the applicant had met all the Authority requirements for changing its name.

Pursuant to §T.C.A. 65-4-113,

IT IS THEREFORE ORDERED:


1. That the petition of Buehner-Fry, Inc. to change its name to Buehner-Fry, Inc. dba Resort Operator Services and DirectDial USA be hereby approved.
2. That Buehner-Fry, Inc. dba Resort Operator Services and DirectDial USA be authorized as an operator service provider and/or reseller of telecommunications services for intra-state service in Tennessee as specified in its application on file with the Authority.
3. That said company shall comply with all applicable Authority rules and regulations.
4. That this Order shall be retained as proof of certification with this Authority, and may be used to obtain appropriately tariffed service and billing arrangements from Authority authorized telecommunications service providers.


Comes now Buehner-Fry, Inc. and submits this petition to amend its existing Certificate of Convenience and Necessity as follows:

1. On May 29, 1996, Buehner-Fry, Inc. d/b/a Resort Operator Services was issued a Certificate of Convenience and Necessity as an interexchange telecommunications reseller and/or an operator services provider in Case No. 95-03340. As indicated in its application at that time, Buehner-Fry, Inc. provides operator-assisted long distance services to customers using the fictitious name of "Resort Operator Services."

2. Buehner-Fry, Inc. now wishes to expand its service offerings to include direct dial long distance service, which it intends to offer as "Buehner-Fry, Inc. d/b/a DirectDial USA." The Company has registered the name of "DirectDial USA" with the Tennessee Secretary of State, and a copy of that registration is attached as Exhibit 1. The Company will continue to offer operator-assisted service as "Resort Operator Services."

Wherefore, Buehner-Fry, Inc. requests that its Certificate of Convenience and Necessity be amended to reflect the fictitious names of "Resort Operator Services" and "DirectDial USA."
