ORDER GRANTING CANCELLATION OF AUTHORITY TO PROVIDE CUSTOMER OWNED COIN OR COINLESS OPERATED TELEPHONE SERVICE

This matter came before Chairman David F. Jones, Commissioner Herbert H. Hilliard and Commissioner Kenneth C. Hill of the Tennessee Public Utility Commission (the "Commission"), the voting panel assigned to this docket, at a regularly scheduled Commission Conference held on October 23, 2017. On April 15, 1997, Century Telephone, as parent company of Century Telephone of Claiborne, Inc. (ID No. 126092), Century Telephone of Ooltewah-Collegedale, Inc. (ID No. 126350), and Century Telephone of Adamsville, Inc. (ID No. 126349) (collectively, "CenturyTel"), filed an Application to provide Customer Owned Coin or Coinless Operated Telephone ("COCOT") service within the State of Tennessee on behalf of the three CenturyTel companies. During a Commission Conference held on April 29,

1997, the Commissioners found that the CenturyTel companies had met all the requirements of Tenn. Comp. R. & Regs. 1220-4-2-.43 through 1220-4-2-.45 to provide COCOT service in Tennessee and approved the Application.

On October 6, 2017, the Commission received requests from the three CenturyTel companies to cancel their COCOT authority. Based upon careful consideration of the record in this matter, the Commissioners voted unanimously to grant the requests for cancellation of authority to provide COCOT service in Tennessee.
