Dear Chairman Morrisson,

Tennessee Wastewater Systems, Inc. hereby provides notice of its intent to provide wastewater service to Phase 2 of the Daventry subdivision identified as a portion of Map 81, Parcel 15, 19<sup>th</sup> Civil District in Williamson County pursuant to T.C.A. 65-4-201.

The Commission granted TWSI a CCN in Docket 95-00293 to provide wastewater service to the Milcrofton Utility District in Williamson County. The Daventry subdivision is constructed such that it falls within two separate water utility districts. Phase 1 falls within Milcrofton's water service territory and Phase 2 falls within the Nolensville College Grove Utility District service territory. TWSI's certificated territory includes Phase 1, but not Phase 2. TWSI also holds a CCN for the adjoining property to the east of Daventry Phase 2, Clovercroft Preserve (Docket 14-00062).

Neither Williamson County nor NGCUD provide wastewater service to Daventry Phase 2 and requests for wastewater service from each entity have been denied. The wastewater system has been constructed to serve the entirety of the Daventry subdivision and has been conveyed to TWSI to provide service to both phases.

Enclosed with this letter is a map detailing the property showing Daventry Phases 1 and 2, proximity of the property to Clovercroft Preserve, and the wastewater treatment property and denial of service letters from the Williamson County mayor and the Nolensville College Grove Utility District.
