AUTHORITY TO PROVIDE RESOLD TELECOMMUNICATION SERVICES**




WHEREFORE, having considered the request of Cash 2 Go, LLC to cancel their authority, the Authority finds that such a cancellation should be granted.

IT IS THEREFORE ORDERED:




Application for Authority to Provide Operator Services and/or Resell

IT IS THEREFORE ORDERED:



The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Tennessee H.B. 9052, do hereby adopt the following Articles Of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Cash 2 Go, LLC

SECOND: The latest date on which the Limited Liability Company is to dissolve is January 31, 2037.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Tennessee H.B.. 9052, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Tennessee is 630 South Church Street, Murfreesboro, Tennessee 37130, and the name of the initial registered agent of the Limited Liability Company in Tennessee at that address is Percy E. Dempsey, III.

FIFTH: The principal executive office of the Limited Liability Company is in the County of Rutherford at 630 South Church Street, Murfreesboro, Tennessee 37130.

SIXTH: The Limited Liability Company is to be managed by a Board of Governors. The names and addresses of the initial Chief Manager of the Board of Governors is:

David A. Jones, having an address at 339 East College Street, Murfreesboro, Tennessee 37130.

SEVENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: The remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

NINTH: The Limited Liability Company may not expel a Member without cause.

TENTH: The names and addresses of the Members and Organizers of the Limited Liability Company are: David A. Jones, having an address at 339 East College Street, Murfreesboro, Tennessee, 37130, Donna P. Jones, having an address at 339 East College Street, Murfreesboro, Tennessee, 37130, and Diversified Investments, LLC, having an address at P. O. ELEVENTH: At the date and time of formation of the Limited Liability Company, there are two or more Members of the Limited Liability Company.


TWELFTH: At the date of filing of these Articles Of Organization, the Limited Liability Company has three Members.


THIRTEENTH The Limited Liability Company does not have the power to expel a Member.


FOURTEENTH: The Members, parties (other than the LLC) to a contribution agreement or a contribution allowance agreement do not have preemptive rights.
