

TO AMEND APPLICATION**

Nashville Gas Company (Nashville Gas) hereby respectfully requests the Authority to grant it permission to amend the petition filed in the above captioned docket on May 12, 1998 to (1) delete paragraph 6 thereof and (2) replace the "WHEREFORE" paragraph on page 3 thereof with the following language:

"WHEREFORE, it is respectfully requested that the Authority (1) approve the Gas Redelivery Agreement and authorize Nashville Gas to provide the natural gas services and to charge the rates set forth therein effective January 1, 1998, (2) permit Nashville Gas to recover 90% of its margin losses associated with the Gas Redelivery Agreement in the manner set forth above, and (3) grant such other relief as may be necessary or appropriate."
