IXC Communications Services, Inc., formerly known as IXC Long Distance, Inc. (hereinafter "IXC-CSI"), hereby requests the Tennessee Regulatory Authority ("Authority") to amend its certification to reflect its change of name. The name change occurred on June 16, 1998. On June 26, 1998, IXC-CSI and Switched Services Communications, L.L.C. ("SSC") sent an application to the Authority regarding the proposed merger of SSC into IXC-CSI. The merger application also informed the Authority of IXC-CSI's name change.

Enclosed is IXC-CSI's amended Certificate of Authority as filed with the Tennessee Secretary of State. As reflected in the attached documentation, the amended Certificate of Authority became effective on July 16, 1998. Tariffs reflecting the name change are being prepared and will be filed after the name change is approved by the Authority.

IXC-CSI received its authorization to provide resold interexchange telecommunications services in Tennessee under the name IXC Long Distance, Inc. on October 13, 1995, in Case No. 95-03221. IXC-CSI respectfully requests that the Commission change its certification to reflect its name change.


