Dear Mr. Waddell:

Eclipse Telecommunications, Inc., formerly known as Network Long Distance, Inc. (hereinafter "Eclipse"), hereby requests the Tennessee Regulatory Authority ("Authority") to amend its certification to reflect its change of name, which occurred on June 3, 1998. In a February 4, 1998 letter to the Authority, Eclipse (then Network) and IXC Long Distance, Inc. ("IXCLD") notified the Authority of their intention to transfer control of Network to IXCLD. The same letter also advised the Authority that Network would then become Eclipse Telecommunications, Inc. The closing date of the transaction also was June 3, 1998.

Enclosed is Eclipse's amended Certificate of Authority as filed with the Tennessee Secretary of State. As reflected in the attached documentation, the amended Certificate of Authority became effective on July 16, 1998. Tariffs reflecting the name change are being prepared and will be filed after the name change is approved by the Authority.

Eclipse received its authorization to provide resold interexchange telecommunications services in Tennessee under the name Network Long Distance, Inc. on August 2, 1995, in Case No. 95-02659. Eclipse respectfully requests that the Authority change its certification to reflect its name change.
