Hello Chris,

Prior to 2014, West Kentucky Networks, Inc. (WK.Net ID# = 128319) was a separate company that was a wholly owned subsidiary of West Kentucky Rural Telephone Cooperative Corporation, Inc. (WK&T ID# = 126346). As of January 1, 2014, WK.Net was merged into WK&T and ceased to exist as a separate entity.

Because WK.Net no longer exists, a Statement of Gross Earnings and Computation of Inspection Fee (Form UD-16) was not filed in 2015. In addition, WK&T is a cooperative organization and is not regulated by the TRA and thus does not submit a UD-16 report.

NAME

WHO MAY SIGN

The articles of dissolution must be signed by an officer or the chairman of the board.

PRINCIPAL OFFICE ADDRESS

The principal office is the office (in or out of this state) so designated in writing with the Office of the Secretary of State where the principal designated office of the business entity is located.
