I am in receipt of your letter dated June 4, 2012 regarding the letter of credit cancellation notice from Citibank for the above-referenced entity and a phone message this week requesting that BT Communications Sales LLC ("BT") provide a written request for the cancellation of its licenses on BT's letterhead so it is not in violation.

Accordingly, please accept this as official documentation that BT requests cancellation of its CLEC/IXC licenses, Docket No. 99-00419. The reason for this request is because BT has not and currently is not providing services in the State of Tennessee. While we anticipate activating service at some point in the future, since BT is not currently providing services it has decided not to reinstate the letter of credit until such time as BT commences services requiring CLEC/IXC authority.


Application for Authority to Provide Operator Services and/or Resell Telecommunications Services in Tennessee Pursuant to Rule 1220-4-2-.57.

---ORDER---

This matter is before the Tennessee Regulatory Authority upon the application of the above-mentioned company for certification as a reseller or telecommunication operator service provider in Tennessee. The TRA considered this application at a Conference held on October 26, 1999 and concluded that the applicant has met all the requirements for certification and should be authorized to provide operator services and/or resell telecommunications services on an intrastate basis.

IT IS THEREFORE ORDERED:

1. That the above-mentioned company is issued a Certificate of Convenience and Necessity as an operator service provider and/or reseller of telecommunications services for state-wide service in Tennessee as specified in its application on file with the Authority.
2. That said company shall comply with all applicable state laws and TRA rules and regulations.
3. That this order shall be retained as proof of certification with this Authority, and may be used to obtain appropriately tariffed service and billing arrangements from Authority authorized telecommunications service providers.



**ORDER GRANTING APPROVAL OF THE PETITION OF

This matter came before Director Deborah Taylor Tate, Director Pat Miller and Director Ron Jones of the Tennessee Regulatory Authority (the "Authority"), the voting panel assigned to this docket, upon the petition of Concert Communications Sales LLC to change its operating name, which was filed on January 3, 2003. The Authority considered this request at a regularly scheduled Authority Conference held on June 16, 2003 and concluded that the applicant has met all the TRA requirements for changing its operating name pursuant to Tenn. Code Ann. § 65-4-113. Concert Communications Sales LLC holds a Certificate of Public Convenience and Necessity to provide telecommunications services in Tennessee.

**IT IS THEREFORE ORDERED THAT:**

1. The petition of Concert Communications Sales LLC for name change to BT Communications Sales LLC is approved.

2. Any party aggrieved with the Authority's decision in this matter may file a Petition for Reconsideration with the Authority within fifteen (15) days from the date of this Order.
