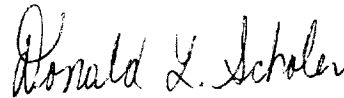

Dear Don:

Please let this letter serve as a written response by Lynwood Utility to the TRA request for additional information dated October 11, 2000. The following is some background information that should respond to each of the seven requests made in Mr. Waddell's letter:

1. In preparing the "Bill Adjustment for Irrigation," we studied a variety of different ways to make a billing adjustment for irrigation. We looked at the impact to revenue based on the average six months winter usage multiplied by 1.25, average six months winter usage multiplied by 1.5 and average six months winter usage multiplied by 2.0. We also had to consider the current and potential ability of the City of Franklin and H. B. & T. S. Utility District to bill sewer charges for us and their willingness to implement any irrigation adjustment rule adopted. In the event neither Franklin nor H. B. & T. S. Utility District is willing to implement the irrigation adjustment rule through programming changes in their billing software, Lynwood had to consider the resources and personnel which would be required to manually make these adjustments. The explanation of each condition for adjustment follows:
 - a. Lynwood is attempting to work with two different water suppliers to bill its sewer services. Currently, Franklin is billing sewer service for Lynwood; H.B. & T.S. Utility District is not. Each water supplier has its own billing software and has its own policies and procedures for billing. At this time Lynwood cannot state how its billing will be handled next spring when the irrigation adjustment rule will first be applied. Unless H.B. & T.S. Utility District agrees to begin providing billing services for Lynwood before next spring, Lynwood may still have two different billing systems in place. If H.B. & T.S. Utility District decides it will not bill for Lynwood, Lynwood may have decided to handle all of its own billing by next spring. As of the date of this letter, Franklin has expressed reluctance about implementing any change in its billing program for Lynwood for an irrigation adjustment. Because of this uncertainty in its billing arrangements, Lynwood feels the rule must include a requirement that the customer request the irrigation adjustment in

the event Lynwood will have to manually make the adjustments next spring. In the event Lynwood has in place a system where a software program can automatically calculate the adjustment either through the water providers or its own billing software, the irrigation adjustment could become automatic, and Lynwood would seek to change this condition when and if that becomes available. Moreover, the billing adjustment for irrigation is being implemented as a benefit to the customers of Lynwood so that they are not billed for water being used for irrigation (that is not being treated at the treatment plant). Only the customer knows if he has been using water for irrigation purposes. Therefore, it seems practical that it should be incumbent upon the customer to request the irrigation adjustment.

- b. Lynwood decided to define the October through March billing periods as the “Winter” months in which it is unlikely that any irrigation will be done. Assuming that no irrigation is done during those months, it seemed reasonable to average the six winter months to determine an average monthly water usage. Lynwood believes that most customers use more water on average during the summer. The basis for this belief is that customers may take additional baths or showers on a daily basis. Also, children and parents are more likely to be at home during the summer days increasing the likelihood of water use for purposes other than irrigation. On that basis, Lynwood decided to take the average winter monthly water usage and multiply by 1.25 to establish a basis upon which irrigation adjustments could be made.
 - c. Lynwood is encouraged by TDEC to provide each of its customers with a capacity of 350 gallons per day at the treatment plant. Converted to a monthly basis, Lynwood strives to maintain treatment plant capacity of 10,500 gallons per customer. Lynwood defined the customer’s average monthly water usage during the October – March billing periods to be at least 8,000 gallons based on the calculation of 8,000 gallons times 1.25 which equals 10,000 gallons. It does not seem appropriate to make billing adjustments for customers who are using less than the minimum treatment plant capacity that Lynwood is required to maintain.
 - d. Since the billing adjustment is intended to address water used for irrigation, Lynwood required the customer’s high water usage be caused by irrigation.
 - e. Since the billing adjustment for irrigation benefits the customers of Lynwood, Lynwood believes that it is imperative that adjustments be given only to customers who are current on their account for sewer service. Lynwood views this as an incentive for the customer to keep his account current.
2. Please find included herein an excel spreadsheet that includes the last twelve months water usage by customer by water provider (City of Franklin is Attachment 1A and

H.B. & T.S. is Attachment 1B). This information was supplied by the City of Franklin and H.B. & T.S. The spreadsheet shows the customer name, account number, service address and water usage per month for the last twelve months. It then calculates the average monthly water usage for the Winter months (October through March billing periods). The adjusted average monthly usage for the winter months will be the greater of the average monthly water usage or 8,000 gallons. Then the spreadsheet calculates the amount of adjustment that the customer would have been entitled to during the most recent "Summer" months (the April through September billing periods). The spreadsheet also calculates the number of adjustments that would have to be made if all customers requested the bill adjustment for irrigation.

3. The excel spreadsheet shows the actual customers bills and what effect the current rates and the proposed adjustment for irrigation has on their bills.
4. If you add the total City of Franklin amount of adjustments (\$60,705.18) to the H.B. & T.S. amount of adjustments (\$5,787.00), the total amount of adjustments is \$66,492.18. This is how we arrived at the decrease in annual revenue of \$66,500.
5. Please find attached herein the revenue received and receivable by Lynwood since our rate increase in March of 2000 (Attachment 2).
6. Please find attached herein, by month, the usage data on Walnut Grove Elementary School for the last 24 months (Attachment 3).
7. Since the hearing Lynwood representatives have met with and discussed again the \$787.50 rate with personnel in the accounts payable section of the Williamson County School Board. One of the persons with whom the issue was discussed suggested that Lynwood speak with The Parent Company who was the contractor who built the Walnut Grove Elementary School. An employee of The Parent Company retrieved documents on the construction of Walnut Grove Elementary School. They found two documents that are attached which address the sewer rate (Attachment 4). By letter dated April 27, 1989, Lynwood wrote to The Parent Company and set forth the conditions under which sewer service would be made available to the school. This letter contains a rate of \$735 for the school and the method used to calculate the rate. As you can see the rate used is \$1.40 per 1000 gallons which is in the commercial rate in the Lynwood tariff. The monthly rate was calculated using an assumed flow based upon 600 students at 35 gallons per day per student for 25 days. The second document is an application for the District's engineer to install the sewer facilities for the school signed by Rebecca H. Schwab who at the time was the Director of the Williamson County School System which references the \$735 per month rate.

Lynwood does not know why it began charging \$787.50 per month rather than the \$735 per month referenced in these two documents. As previously indicated to the Authority, the \$787.50 has been charged since at least 1992. Apparently, the commercial rate in its tariff of \$1.40 per 1000 gallons was used in calculating this rate. In all probability the additional \$52.50 resulted from a change in the assumed flow that was used to compute the rate, but Lynwood has been unable to find any document which indicates why \$787.50 was charged rather than \$735.

We have received and reviewed your request for sewer service for the referenced project. The project consists of an 8" gravity sewer, one grinder sewage pump station, and 4" force main to service Walnut Grove Elementary School, which will have a capacity of 600 students.

The Lynwood Utility Company has the available capacity to receive and treat sewage from the proposed 600 student elementary school and will accept sewage provided that the following criteria are met:

- 1) The sewage system shall provide service for restrooms, kitchen, and lavatories only. Floor drains, roof drains and storm drains shall not be allowed to enter the collection system.
- 2) The kitchen shall be provided with a grease trap which shall be cleaned and maintained according to a maintenance schedule.
- 3) The sewage system (gravity lines, pump station and force main) shall be installed and maintained by the Williamson County School Board.
- 4) All necessary easements shall be acquired by the Williamson County School Board.
- 5) The sewage system design drawings shall be approved by the Tennessee Department of Health and Environment and the system shall be constructed and tested according to their criteria. The approved pump station design, including pump curves, shall be forwarded to Lynwood Utility Company for reference.
- 6) The flow from the pump station with both pumps in operation shall not exceed 200 gpm at any time.

The force main may be connected to Lynwood Utility Company's collection lines in the manhole at the northwest corner of Cotton Road and Stable Drive. Enclosed are location drawings of the manhole and a force main to manhole connection detail, which shall be incorporated into the design drawings.

The commercial tap fee schedule is \$2.00/gal/day. The tap fee will be \$42,000.00.

The commercial monthly sewer service rate is \$1.40/1000 gal/month. The monthly sewer service charge will be \$735.00/month.
