ORDER ESTABLISHING AMENDED PROCEDURAL SCHEDULE

This matter is before the Administrative Judge of the Tennessee Public Utility Commission (“Commission” or “TPUC”) to amend the procedural schedule for the orderly administration of these proceedings. Tennessee-American Water Company (“TAWC”) and the Consumer Advocate Division of the Office of the Tennessee Attorney General (“Consumer Advocate”), the Parties in this matter, filed the *Parties’ Joint Proposed Procedural Schedule* on March 2, 2026. The Administrative Judge entered the *Order Establishing Procedural Schedule* on March 3, 2026, reflecting the Parties’ agreed schedule.

Subsequent to the entry of the *Order Establishing Procedural Schedule*, the Consumer Advocate notified the Administrative Judge that the date upon which the Parties had agreed for the filing of the Consumer Advocate’s Pre-Filed Testimony, April 3, 2026, is a state holiday. Accordingly, the Parties agreed to adjust the date for the filing of the Consumer Advocate’s Pre-Filed Testimony to April 2, 2026. The Administrative Judge finds that this agreed adjustment to the Procedural Schedule is reasonable and justified. Therefore, the Administrative Judge hereby establishes the Amended Procedural Schedule set forth in **Exhibit A** attached to this Order.

IT IS HEREBY ORDERED.



- Copies of all discovery exchanged between the parties shall be filed with TPUC within three business days of the exchange of information.
- All spreadsheets shall be filed in Excel format with working formulas intact.
- Any Pre-filed Testimony should include all supporting worksheets in Excel format with working formulas intact.
- Rebuttal Testimony should be limited only to issues raised in the Consumer Advocate's Direct Testimony and should include the page and line number of the Consumer Advocate's testimony that is being rebutted.
