ORDER SUSPENDING TARIFF THROUGH MAY 27, 2026


This matter is before the Administrative Judge of the Tennessee Public Utility Commission (“Commission” or “TPUC”) designated by General Counsel to administer certain preliminary issues that may arise during the preparation of this matter for hearing before the Commission. On February 27, 2026, in accordance with Tenn. Code Ann. § 65-5-103 *et seq.*, Atmos Energy Corporation (“Atmos” or the “Company”) filed a *Petition for Approval of Optional Monthly Facilities Charge for Electronic Flow Measurement Equipment for Demand/Commodity, Interruptible, and Transportation Gas Service Customers* (“*Petition*”) seeking approval of revisions to its tariff to include an optional monthly facilities charge for electronic flow measurement equipment. Along with its *Petition*, Atmos provided Tariff Sheets No. 16 through 24.2. The *Petition* provided proposed revisions to a number of the Tariff Sheets, including its 19th Revised Sheet No. 16, 4th Revised Sheet No. 17, 4th Revised Sheet No. 18, 19th Revised Sheet No.

19, 4th Revised Sheet No. 20, and 16th Revised Sheet No. 24 (“Revised Tariff Sheets”).¹ The Revised Tariff Sheets were filed with an issued date of December 15, 2025, and an effective date of February 1, 2026.²

Tenn. Code Ann. § 65-5-103(a) permits the Commission, pending a hearing and determination, to suspend any rate increase, change, or alteration for an initial period not to exceed three months from the proposed effective date of such increase, change, or alteration and for an additional period not to exceed nine months.³ Because the Commission’s investigation, hearing, and final determination on the Company’s proposed tariff cannot be completed prior to the February 1, 2026,⁴ effective date of the tariff, the Administrative Judge hereby suspends the effectiveness of the tariff through May 27, 2026.

IT IS THEREFORE ORDERED THAT:

The effective date of the proposed 19th Revised Sheet No. 16, 4th Revised Sheet No. 17, 4th Revised Sheet No. 18, 19th Revised Sheet No. 19, 4th Revised Sheet No. 20, and 16th Revised Sheet No. 24, filed by Atmos Energy Corporation on February 27, 2026, is hereby suspended through May 27, 2026, or until further order of the Tennessee Public Utility Commission, whichever occurs sooner.
