The Consumer Advocate has conferred with counsel for Limestone Water Utility Operating Company, LLC (“Limestone” or “Company”) and this request is unopposed. After conferring with Limestone, the Consumer Advocate requests that the deadline for the second round of discovery requests be moved from August 6, 2026, to August 7, 2026, and that the due date for responses be moved from August 21, 2026, to August 24, 2026. For good cause, the Consumer Advocate would note that pre-filed testimony in another docket is due on August 6, 2026, in Docket 26-00042.
